Dr Kálmán Barátosi informed the Presidium about the earlier letter of Dr Alojzy Dzierzega, Presidium Member of .Switzerland in which he recommended Mr Juergen Mayer as Presidium Member of Switzerland. Mr Mayer works for the Leica Geosystems AG, Heerbrugg, he is the Program Director of TPS (Total Station, Levels etc).

Mr Michael Livingstone Blevins reported about the work of the Awarding Committee for excellent young authors. The Committee led by Mr Michael Livingstone Blevins was established on the 34th Presidium Meeting in Leoben, 2006. Mr Michael Livingstone Blevins received the papers of the young author; he sent them to the members of the Committee who represented the ISM Commissions.

Unfortunately, not all the members of the Committee sent back the qualification and proposals for the two best papers to reward. "Dr Kálmán Barátosi reported about the discussion between FIG and ISM held in the last evening:

The participants reviewed the former co-operation events between FIG and ISM.

Those were the Conferences in New York, Cairo, Accra, the Congresses in Fuxin-Beijing and Munich, and ISM Presidium Meetings in Cracow and Leoben. After discuss the Parties accepted the followings:

- 1. "The Understanding of Co-operation between the International Society for Mine Surveying and the International Federation of Surveyors" signed in Cracow in 2000 was a good base for the further co-operation.
- 2. The FIG and the ISM have three fields for cooperation: education, instrumentation-measuring and engineering surveys.

Dr Barátosi will send Prof Kopácik the names and addresses of the ISM representatives dealing with the fields of the relating topics.

Prof Kopácik will send Dr Barátosi the names and addresses of the FIG representatives dealing with the fields of the relating topics.

- 3. Each organisation finds solutions for possibilities to put links to reach the partner organisation from its homepage.
- 4. The FIG will prepare the thematic of the Stockholm Conference then FIG send ISM it to propose further topics for the Conference.
- 5. Both partners search the further fields for co-operation between FIG and ISM.

Decision 9th: The Presidium accepted the report as the base of the future co-operation between FIG and ISM."

Prof Kopácik sent me the names and addresses of the FIG representatives dealing with the fields of the relating topics.

The FIG representatives are:

Education: Prof Béla Márkus, Hungary, Chairman of the FIG Commission 2

Instrumentation-measuring: Prof Rudolf Staiger, Germany, Chairman of the FIG Commission 5

Engineering surveys: Prof Alojz Kopácik, Slovak Republic, Chairman of the FIG Commission 6

I sent Prof Kopácik the names and addresses of the ISM representatives dealing with the fields of the relating topics.

The ISM representatives are:

Education and Instrumentation-measuring: Dr Ralf Schulte, Germany, Chairman of the ISM Commission 3 and Co-chairman of the ISM Commission 1

Engineering surveys: Prof Edward Popiolek, Poland, Chairman of the ISM Commission 4

The possibility and the frame of the cooperation exist and I hope that the cooperation will be good and useful for both parties.

Mr Michael Livingstone Blevins asked who the ISM responsible person is for the contact to the FIG.

Dr Kálmán Barátosi and others: According to the Statutes of the ISM, the president represents the ISM and the president can ask one of the Presidium Members to represent the ISM at any events of other organisations.

Report of Mr Michael Livingstone Blevins about the 36^{th} Presidium Meeting and about the XIV Congress:

The 36th Presidium Meeting is to be hosted by South Africa. The Institute of Mine Surveyors of South Africa (IMSSA) has established an ISM sub-committee to address the Presidium Meeting in 2008 and the XIVth International Congress in 2010.

It has been proposed that the 36th Presidium Meeting be held in the city of Kimberley in the Northern Cape region, as this area is rich in diamond mining history. It is also planned to visit the De Beers Finsch Mine underground diamond mine, to see a fully-automated mining operation. Permission to undertake this visit will be requested from De Beers in 2008.

There are regular flights from Johannesburg to Kimberley and flight connections are easily made.

The dates for the meeting have yet to be decided, however, these will take into account the European university calendar, in an effort to ensure availability of Presidium members.

Agenda 12

Dr Kálmán Barátosi spoke about the well-known fact that the next ISM Congress would be organised in South Africa in 2010 and the next ISM president should be elected from South Africa at the Members Assembly. Therefore Mr Michael Livingstone Blevins was elected as ISM Vice President in Ukraine, in 2005. He read the CV of Mr Michael Livingstone Blevins as it follows:

Mr Michael Livingstone Blevins was born in 1960 in South Africa. As the son of a mining engineer, he grew up in "the shadow of the headgear" living in mining communities in South Africa and Zimbabwe (then Rhodesia) during his formative years.

He completed his secondary and tertiary education in South Africa, in Johannesburg and Cape Town respectively.

He started his career as a Pupil Survey Officer after being awarded a bursary to study survey by the Department of Surveys and Mapping (government department) in Cape Town.

Following completion of his studies, he joined the mines in January 1983, working on Coal, Diamond and Gold mines in South Africa and Namibia until 1995, rising to the position of Chief Surveyor.

For the past 12 years, he has been based at the offices of Anglo American Plc (a large global mining company) in Johannesburg, where he holds the position of Head of Group Survey and manages a multi-discipline group of senior professionals. His technical responsibilities include consulting, oversight and assurance, and knowledge management for local and international operations. He advises the company on legal and best practice compliance issues, technology systems and the maintenance of technical capacity and capability.

He holds mine surveying certificates of competency for South Africa and Namibia. He is registered as a Professional Mine Surveyor with the South African Council for Professional and Technical Surveyors, statutory body on which he has served since 1998.

He serves on the Mining Sub-committee of the Minerals Education Trust Fund, an Industry-funded organisation that supports minerals education at universities.

He is a past President of the Institute of Mine Surveyors of South Africa, of which he is a Fellow, and has served on its Council for many years, as well as on its Technical and Education committees.

He is currently Vice President of the ISM since 2005.

He is married to Isobel. They have two sons at university aged 22 and 20 years.

Dr Kálmán Barátosi asked the Presidium Members whether anybody had any remarks or questions. No.

Dr Kálmán Barátosi asked the Presidium Members to vote about acceptation of the candidature of Mr Michael Livingstone Blevins, ISM Vice President as the new President.

Decision 10th: The Presidium will propose the Members Assembly to elect Mr Michael Livingstone Blevins as new ISM President.

Dr Kálmán Barátosi said that the subsequent ISM Congress in 2013 will be organised in Germany. The new ISM Vice President should be elected from Germany according to the Statutes of ISM. He asked the German Presidium Members for the person of the candidate.

The candidate was Prof Axel Preusse Chairman of the ISM Commission 1.

Dr Kálmán Barátosi read out the CV of Prof Axel Preusse as it follows:

Master degree in mine surveying and mining subsidence engineering at Clausthal University, Germany (1983)

PhD degree of Clausthal University in Mining Subsidence Engineering (1990)

11 years with RAG Coal (Head of Department Exploration and Deposit, Research and Development)

Since 1997 Director of the Institute for Mine Surveying and Mining Subsidence Engineering and Geophysics in mining of Aachen University, Germany

More than 120 papers

Honorary functions:

Chairman Mine Gas Initiative NRW, as part of EnergieAgentur.NRW Board of Association DMV Member of ISM Presidium Member of APCOM council

Married to Dr Lilyana Preusse, 2 kids (20 and 17 years)

Dr Kálmán Barátosi asked the Presidium Members whether anybody had any remarks or questions. No.

Dr Kálmán Barátosi asked the Presidium Members to vote about acceptation of the candidature of Prof Axel Preusse as new Vice President.

Decision 11th: The Presidium will propose the Members Assembly to elect Prof Axel Preusse as a new ISM Vice President.

Prof Axel Preusse: There will be changes in the Chairmanship of the ISM Commission 1 and 3 because I will be the new Vice President. Probably Dr Ralf Schulte will elect as Chairman of the Commission 1 and Mr Juergen Mayer as Chairman of the Commission 3 at the Commission Meetings.

Decision 12th: The Presidium agreed with the proposal.

Agenda 14

Commission 1. Prof Axel Preusse gave the written report for the Minutes, and it is attached to the Minutes. Dr Ralf Schulte spoke about the new online possibility on the website.

Commission 2. Prof Vladislav Popov: The Commission cannot reach successes with too little membership. I organized a meeting in Moscow in 2006.

Commission 3. Dr Ralf Schulte gave a report in written material and it is attached to the Minutes. There was a commission meeting in Prague in 2005. The next new chairman will have to continue the work.

Commission 4. Prof Popiolek: There were two commission meetings. One of them was in Freiberg, the other one was in Krakow. The second one was organized in memory of Professor Drzezla. The number of participants in Freiberg is 37 (6 countries), and 18 people from 5 countries were in Krakow. The next meeting to be planned will be here.

Commission 5. Dr Martin Vrubel gave a report in written material and it is attached to the Minutes. There were two commission meetings. One of them was in Prague together with the Commission 3 in 2005. It took two days. There were 16 participants from 5 countries. The second one was in the frame of the Geo-Mine Surveying Conference in Slovak Republic in 2006, under the auspices of Dr. Kálmán Barátosi, president of ISM. Here there were 80 participants (8 ISM members) and 62 papers.

Commission 6. Prof Yu Changxing spoke about the Commission Meeting held in Hanoi in Vietnam. There 65 participants attended, and 25 papers were delivered. He will give a report in written form and it will be attached to the Minutes. He emphasized the importance of coal mine gas exploitation which is a hot topic and joint project possibility between China and Vietnam. The next commission meeting could be in Canada or Australia.

Agenda 10

All the present presidium members have got the copies of the Report of Michael Livingstone Blevins who asked them to read the Report and to discuss it after reading on Thursday. The Report is attached to the Minutes.

Prof Frank Hart had a remark about the Commissions. The Commissions cannot be strictly regulated. The education is not a leading industry; the regulations and the measuring instrument technologies are the most important themes.

Prof Eric Ludvigsen said that it was necessary to hold the Presidium Meeting on Wednesday too. Meanwhile they will hold a short meeting about the ISM languages.

Wednesday, 26 September 2007.

Dr Kálmán Barátosi greeted the Presidium Members and said that the Presidium continued the Meeting. He gave the floor to Prof Edward Popiolek.

Prof Edward Popiolek: The Commission 4 held a Meeting and the present Commission Members elected Prof Ryszard Hejmanovsky (Poland) as the new Chairman of the Commission at the Meeting.

Dr Kálmán Barátosi: Prof Ryszard Hejmanovsky as Commission Chairman is automatically Presidium Member too.

Decision 13th: The Presidium accepted Prof Ryszard Hejmanovsky as the new Chairman of the Commission 4 and as a new Presidium Member.

Dr Ralf Schulte: The Commission 1 and 3 held a common Meeting and the present Commission Members elected me as the new Chairman of the Commission 1 and Mr Juergen Mayer as the new Chairman of the Commission 3 at the Meeting.

Dr Kálmán Barátosi: Mr Juergen Mayer as Commission Chairman is automatically Presidium Member too.

Decision 14th: The Presidium accepted Dr Ralf Schulte as the new Chairman of the Commission 1 and accepted Mr Juergen Mayer as the new Chairman of the Commission 3 and as a new Presidium Member.

Agenda 8

Prof Erik Ludvigsen: There was a meeting about the languages of the ISM attended by Dr Ralf Schulte, Prof Erik Ludvigsen, Dr Gareth Powell, Prof Jacek Szewczyk, Prof Vladislav Popov and Mr Konstantin Georgiev. The proposal of the Committee is as it follows (he gave the proposal to the president in written form):

"The task of the language Commission has been to consider if ISM should reduce the number of official languages to one: English. This is the norm in many other technical societies.

The Commission supported the idea, but decided as a first step to recommend that English would be the working language and continue the evolution that has happened during the previous years.

Concerning the Congress:

All papers should have an English title and abstract.

We should encourage specialists who give the paper in Russian to translate to English the slides used, or to have the slides in both languages. The Commission also discussed details concerning simultaneous translation and the publication of papers between Russian and English. It was concluded that this would be a topic for consideration between the Russian speaking community and the organisers.

Concerning the Presidium and the Commissions:

Recognise that language is a barrier.

Establish during meetings the infrastructure that enables us to have both computer support and the support of colleagues for communication and the exchanges of ideas."

Dr Kálmán Barátosi asked whether this proposal is a common proposal of the participants of the Commission. If it is, he asked the participants of the Commission to sign it.

It came not to signing. There was an extended discussion. The Russian and Ukrainian Presidium members wanted to read it in Russian. The proposal was translated into Russian in place.

Prof Vladislav Myrnyy asked why the Presidium spoke about this theme and he said the Russian speaking countries did not agree with the proposal.

Mr Michael Livingstone Blevins said that he missed the new generation from the Russian speaking countries who spoke languages.

Mr Carl Vender said that it was a big problem to find Russian translators in 1991.

Mr Konstantin Georgiev said that the Congresses should be organised with two languages: Russian and English.

Dr Kálmán Barátosi said that it was clear that the Presidium was not able to make decision about this theme. He asked the Language Commission to work out a proposal for the next Presidium Meeting.

Decision 14th: The Presidium accepted the proposal of the President

Tuesday, 27 September 2007

Prof Dr Gyula Sallai the Vice Rector of the BUTE held a kind reception for the Presidium Members and for their wives being present at 8 o'clock in the evening.

The Presidium Meeting continued after the reception.

Dr Kálmán Barátosi reminded that the Presidium Members had not discussed the Agenda 10. Mr Michael Livingstone-Blevins distributed the Presidium Members the written material on 24th of September and he asked the Presidium Members to read the Report so that they would be able to discuss it at the last meeting. Dr Kálmán Barátosi gave the floor to Mr Michael Livingstone-Blevins.

Mr Michael Livingstone-Blevins hoped the Members had read his Report. He emphasised some thoughts:

- the ISM Commissions are suitable and proper for the work of the ISM,
- the capacity of the Commissions are not enough,
- all the Presidium Members and Commission Chairmen should examine and reconsider the work of the Commissions.
- the work field (scope of activities) of each Commission must be identified and declared,
- the commissions should utilize the ISM homepage to share knowledge by publishing comprehensive activity reports and results of work projects,
- the youth should be recruited to the Commission,
- all the Presidium Members should have tasks for the ISM.
- all the Commission Chairmen should ask the Commission Members for <u>active</u> voluntary work in the Commissions,
- the Commission Members should nominate new Members to the Commissions,

- the expectations and requirements for the Commission Chairmen are in the report by Mr Michael Livingstone-Blevins "Report on composition, Number and Activities of Commissions; 19 September 2007" – appended to these minutes.

The task for the Commission Chairmen is to publish work programmes on the website by 31 December 2007. Commission Chairmen should put progress reports on the website every three months and at the Presidium Meeting. In the work programmes it is necessary to state the specific goals, actions, outputs, deadlines for delivery and who will do them.

Mr Michael Livingstone-Blevins required the acceptance and agreement of the Presidium Members to this work.

Dr Kálmán Barátosi asked the Presidium Members to vote about the proposal.

Decision 15th: The Presidium Members being present accepted the proposal and agreed with the ideas unanimously.

Dr Kálmán Barátosi supported the proposal.

Prof Axel Preusse said we could start step by step on this line and the proposals must be followed.

Dr Ralf Schulte agreed with the proposal and he said that the Commission Chairmen would have to work together.

Dr Martin Vrubel agreed with the proposal and he said that common Commission Meetings would have to be organized in 2008 and 2009.

Mr Michael Livingstone Blevins: The work projects should be submitted at the next Presidium Meeting.

Prof Erik Ludvigsen supported the proposal.

Dr Kálmán Barátosi asked Mr Michael Livingstone-Blevins about the format for publishing the results. Will there be books, directives, guidelines, standards or others?

Mr Michael Livingstone-Blevins said that the guideline for practice was a good example. He stated that the most part of the papers were about the rock movement, and therefore it would be possible to prepare a proposal for the best solution.

Mr Carl Vender said that all Commission Chairmen and Members could be "Co-chairman" for a chosen theme and no matter how he/she is called.

Dr Kálmán Barátosi told about the Guideline for Environmental Maps prepared by the Mine Surveying Committee of the Hungarian Society for Mining and Metallurgy. The Guideline was necessary because the ministerial decree regulated the preparing of Environmental Maps but without details.

Prof Vladislav Popov spoke about the events of the Commission 2 held in Moscow. There were always proceedings. It would be good to know which Members of the Commission are active or not active. New delegates should be sent to the Commissions until 31 December.

Dr. Ralf Schulte: One can read it on the ISM website.

Mr Michael Livingstone-Blevins: the first deadline is 31 December 2007 to know the active Commission Members and to prepare the work plans for the future.

Dr Kálmán Barátosi: The Presidium has accepted the proposal of Mr Michael Livingstone-Blevins by voting. I request the Presidium members to take the decisions of the Presidium and the deadline seriously. Thank you for your active participation on the 35th Presidium Meeting, and I am closing the Meeting now.
